Mosaic Works

Selection and group Exhibition:

The selected works will be displayed in a group exhibition called **Opere dal Mondo**, which will be set up in Ravenna, at the Chiostrì Francescani, for the entire Festival period, thus from October 7th to November 26th 2017. Opening day October 7th 2017.

Selection Committee:

Works will be selected at the incontestable discretion of a Committee. Artists will be told about the selection results by July 30th 2017.

Organization:

The transportation of the works to and from the venue is at the artists' charge, as well as the acquisition of any travel documents needed. Further reimbursements for travel expenses might be applied.

Publication:

The organizers intend to publish a collective catalogue of the Festival, including the Exhibition "Opere dal Mondo".

How to apply:

Application is free and addresses the AIMC Members, who are in order with their dues for the current year.

Applicants can apply with **only one work and unreleased works will have a preference.**

In order to apply, it is mandatory to send the following documents by **June 30th 2017**:

- Application Form.
- One or more pictures of the candidate work (photo or digital image, tiff or jpeg form, 300 dpi resolution). The Committee will evaluate works by the pictures at disposal, therefore you are kindly asked to send high quality images.
